RESEARCH PROJECTS (SELECTED)

ON REPRESENTATION AND SOLIDARITY: A RACIALIZED ANALYSIS OF GENDER OPPRESSION IN JUDICIAL DECISIONS (2018 -)

Resorting to decolonial and poststructuralist insights critical to the idea of representation (political, legal and epistemological), I intend to investigate the ways in which law makes invisible and normalizes oppression against non-white women. The premise is that gender oppression cannot be properly understood without its racial dimension. I also want to discuss the possibilities (and limits) of resignification of judicial practices, and the possibilities (and limits) for des / reconstruction of the subjectivity of the judicial actors. This undertaking presupposes, on the other hand, the possibility of forms of solidarity that do not usurp “the other”, the possibility of legal methods capable of translating this solidarity, and, most of all, the increase of representation of non-white actors in the Judicial System. **Funded by CNPq** (Brazil).

GENDER, DEMOCRACY AND LAW: POLITICAL AND EPISTEMOLOGICAL ASPECTS OF THE DISCUSSION ON DOMESTIC VIOLENCE (2014-2017)

Feminist, Queer and decolonial theories have challenged some of the Kantian fundamental assumptions of modern law. This research focused on the analysis of 178 decisions by the Rio de Janeiro State Appellate Courts, aiming at reflecting on three different questions: (i) How to think about the relationship between public and private in relation to gender? Under what conditions is intervention in the private sphere justified, removing alleged aggressors from the home, intervening in their property, limiting their circulation? (ii) how to think about women's individual autonomy in patriarchy? Can we speak significantly of the autonomy of subjects who are victims of oppression and structural violence? are women in situations of violence autonomous to reject state interference supposedly to their benefit? (iii) To what extent is the category “woman” a solid and stable reference for the formulation of public policies, considering the poststructuralists, decolonial and afrodiasporic criticisms? What is the profile of women protected by domestic violence courts? What is the role of stereotypes and gender performances? **Funded by CNPq** (Brazil)

DOMESTIC VIOLENCE AND GENDER DISCRIMINATION: AN INTERDISCIPLINARY ANALYSIS OF THE DOMESTIC APPLICATION OF INTERNACIONAL STANDARDS (2012-2016)

Principal Investigator in a team of three Law Professors and 10 students from different Universities in the state of Rio de Janeiro (Brazil) in the analysis of decisions, recommendations and reports issued by bodies of both UN and Inter-American Human Rights Systems regarding gender violence and domestic violence, in special.
